## 2011 Year in Review

**Jan. 7**

Pfc. Belleau Wood, the depot mascot, is promoted to lance corporal. Belleau is an English bulldog and her responsibilities include attending ceremonies and boosting morale wherever she goes. Belleau assumed her responsibilities from Molly Marine Nov. 10, 2009.

**Jan. 10**

Marine Corps Recruit Depot San Diego's Business Process Office received the Outstanding Continuous Process Improvement Implementation Achievement Award and Continuous Process Improvement Excellence Award.

The awards were for runner-up for best organizational-wide CPI deployment in the supporting establishment and top CPI implementation leader.

**Jan. 31**

Marines from MCRD San Diego and WRR competed in the annual Depot Competition in Arms Program. 12th Marine Corps District took first place in the rifle team match and 9th Marine Corps District placed first in the pistol team match.

**March 25**

Col. Carl F. Huenefeld, former chief of staff, retires aboard the depot at Shepherd Memorial Field. Huenefeld, who joined the Corps in June 1971, now works as the assistant chief of staff, G-1 (Manpower).

### *Substance Abuse Counseling Center earns recertification*

**March 1** – The Substance Abuse Counseling Center at Marine Corps Recruit Depot San Diego received a three-year recertification in March as a top program by the Commission on Accreditation for Rehabilitation Facilities International.

The SACC was recognized for having an outstanding program for its outpatient treatment which includes education, outreach services and counseling for alcohol and other drug addictions for adults.

Not only did MCRD obtain this re-accreditation, but they were able to place in the top three percent of the nation. The CARF surveyors found no discrepancies with their program.

CARF International standards ensure patients receive the best quality care. They have surveyed hundreds of thousands of programs throughout North and South America, Europe, Africa and Asia since it was founded in 1966.

### *Company G recruits hit marksmanship landmark*

**March 4** – All 389 recruits in Company G qualified on their first attempt at the Table 1 Rifle Qualification, achieving a landmark believed to be the first.

Six PMIs, one assigned to each platoon, are responsible for helping the company qualify. For two weeks each PMI instills the art of basic marksmanship like stance, sight alignment and breath control. Range coaches come to assist the PMIs during the second week to make sure every recruit has the opportunity to ask for help if they are having difficulties.

The drill instructors play an essential role in rifle qualification as well, making sure the recruits understand the importance of marksmanship and ensuring that it is the focus of their training at this point.

“When the drill instructors help out, whether it's going over the marksmanship knowledge or helping them snap in, the recruits become that much more dedicated to what we're trying to do,” said Sgt. Brandon Green, PMI, Field Company.

### *Corps' Battle Color Detachment, Commandant's Own visits depot*

**March 12** – The Marine Corps Battle Color Detachment and Commandant's Own visited the depot and performed a thrilling display of precision drill movements and harmonious music.

The Drum and Bugle Corps and Commandant's Own serenaded the crowd with performances like “Don't Rain on my Parade,” and the 1896 John Philip Sousa classic “The Stars and Stripes Forever.”

Shortly thereafter, the Silent Drill Platoon snapped to attention. The Silent Drill Platoon consists of 24 riflemen who conduct intense drill movements without spoken cadence. The performance includes an impressive rifle inspection sequence involving complex rifle spins and tosses.

The Silent Drill Platoon was put together in 1948 for a one time demonstration for an evening parade. Due to the overpowering response, they became a regular part of parades at Marine Barracks, Washington, D.C.



**April 22** – Ultimate Fighting Championship fighters toured and trained aboard Marine Corps Recruit Depot San Diego and Edson Range. Fighters were lead through an abbreviated crucible and sparred with Marines. Their week-long training culminated when the fighters met with new Marines at graduation.

**April 22** – Sgt. Maj. Michael D. Brookman was appointed as the Headquarters and Service Battalion sergeant major after relieving Sgt. Maj. Donald Jones.

**April 30** – Sgt. Kenneth Carter II, drill instructor, 1st Recruit Training Battalion, was inducted into the Martial Arts Hall of Fame in Los Angeles for being awarded instructor of the year for his dedication to training civilians and military members in various forms of martial arts.

**April 27** – Sgt. Maj. Carlton W. Kent spoke with Marines and recruits at Shepherd’s Field aboard Marine Corps Recruit Depot San Diego for the last time as sergeant major of the Marine Corps. Kent stopped at MCRD San Diego as part of his farewell tour of Marine Corps installations to pass on his legacy before retiring after 35 years. During his service, he spent seven years as a drill instructor and knows firsthand what it takes to make Marines. “It’s always great to get back to MCRD San Diego,” said Kent. “You need to know that the Marines you’re putting out are truly living up to the great, war fighting legacy of our Corps,” Kent said to the drill instructors in attendance.

**May 17** – Marine Corps Recruit Depot San Diego conducted its annual Golden Guardian Exercise May 17. California initiated Golden Guardian in 2004 and uses a different scenario each year to test preparation and response capabilities to disasters at the local, regional, state and federal levels.

**May 25** – Col. Michael J. Lee assumed command of the Recruit Training Regiment from Col. Robert W. Gates at Shepherd Field. Gates assumed duties as the chief of staff for the depot and the Western Recruiting Region.

**May 21** – Three battalions from the Recruit Training Regiment put their wives on the yellow footprints in hopes of giving them a small taste of recruit training. Jane Wayne Day gives wives the opportunity to appreciate the work their husbands put into training the next generation of Marines. The billet of drill instructor is one of the most demanding positions a Marine can hold. Each battalion had a four-woman team who was scored on each event to determine the winner. Scored events consisted of a combat fitness test, flexed-arm hang and final drill.

## Modified swim qualifications prepare Marines for aquatic combat

**April 15** – Swim qualification requirements were modified to better prepare Marines for aquatic combat situations. According to Marine Administrative Message 212/11, the Marine Corps Water Survival Training Program will implement changes outlined in MARADMIN 653/10 published in November 2010. The Marine Corps Water Survival Training Program, or MCWSTP, now consists of three levels. Marines will now qualify as either basic, intermediate, or advanced swimmers. The full camouflage uniform, including boots, is now required for every level of swim qualification. The MCWSTP employs water survival skills of increasing levels of ability. It is designed to reduce fear, raise self-confidence, and develop Marines with the ability to survive in water. Marines who need to fulfill annual training requirements, MCRD swim instructors hold water survival qualifications every Friday at 7 a.m.

Now there are only three different levels of qualification; basic, intermediate and advanced. The changes implemented effective, April 15, focus on making swim qualification more realistic. Marines are now required to wear the full camouflage uniform, including boots.

## MCRDSD hosts National High School Youth Physical Fitness Championships

**May 18** – Marine Corps Recruit Depot San Diego hosted the National High School Youth Physical Fitness Championships, May 18 through 21. Approximately 150 male and female high school students, grouped in teams of six, from across the United States competed in five timed events including: sit-ups, pull-ups, push-ups, shuttle run and standing long jump. The event was run by the Marines Youth Foundation with the depot

supporting the event with personnel, recreational gear, and location for the event. The championships have been held at the depot during Armed Forces weekend for the past several years. At the end of the championship, winning teams were presented with plaques. The overall male and female school winners were both from Emmaus High School, Emmaus, Pa. Marines were de-lighted to showcase the depot and what being a Marine is all about.

## Depot conducts base wide emergency response exercise

**May 25** – Marines, sailors and emergency personnel conducted a base-wide training exercise directed by Headquarters Marine Corps to evaluate emergency management operations to improve coordination, command and control, and recovery from any number of potential threats. The scenario was formulated based on increased numbers of armed threats nationwide. The ‘Fury’ began a vehicle breached the gate and tore through a simulated commanding general’s

event just inside the gate, resulting in multiple injuries. A Marine was also taken hostage in Building 31. Military and civilian authorities including the Provost Marshal’s Office, San Diego Metropolitan Fire Department and Federal Bureau of Investigation all participated in the training. Results of the training emphasized the importance of communication. Ultimately, the exercise will improve overall effectiveness if the base is ever faced with similar situations.

# MCRD, WRR gets new commander

**June 30** – Marine Corps Recruit Depot San Diego and the Western Recruiting Region bid farewell to its commanding general, Maj. Gen. Ronald L. Bailey, who relinquished command to Brig. Gen. Daniel D. Yoo during a change of command ceremony on the commanding general's lawn.

Bailey assumed command of the 1st Marine Division during a ceremony that same day and relinquished command of Marine Corps Recruiting Command, July 5. He expressed his gratitude

to the Marines in his charge, their families and the San Diego community.

Yoo was commissioned in 1985 as an infantry officer. He was previously assigned as the Commandant of the Marine Corps' Military Fellow at the Council on Foreign Relations in New York City.

After thanking Commandant of the Marine Corps Gen. James F. Amos and the senior leadership who entrusted him with this command, Yoo expressed his sentiment towards those now under his charge.

# California educators, counselors engage in live rifle fire exercise

**July 21** – Forty-one high school administrators, teachers and counselors from Sacramento and San Francisco participated in live-fire weapons training with the M-16A2 service rifle at Weapons Field Training Battalion aboard Camp Pendleton during an educator's workshop.

This workshop is one of 12 held throughout the year aimed toward providing first-hand knowledge of the recruiting process and recruit training to educators from Western Recruiting Region.

Each workshop affords educators the opportunity to visit WFTBn to witness and experience recruit field and weapons training.

Not all educator workshop group has the opportunity to undergo the live fire training. Those who do have the chance to further experience the recruit training experience.

"We do this to give them a real experience of what recruits do," said Staff Sgt. Brody Goldthwaite, night chief, Receiving Company, Support Battalion. "For a lot of them it's their first time holding a weapon. They get to feel the same fear the recruits go through when they get live rounds."

The educators were supervised by primary marksmanship instructors while they fired. The PMIs taught them how to properly fire a weapon and safety procedures that go along with it.

**Aug. 23** – Colleen Gaydos, a professional staff member of the Senate Appropriations Committee and Lt. Cmdr. John Collins a navy congressional liaison officer with the Appropriations Matters Office, visited Marine Corps Recruit Depot San Diego Aug. 23. They were on the depot to gain an understanding of the requirements and challenges in processing, training and transforming recruits into Marines.

After being briefed about the depot’s facilities they toured the base, observed recruit training and inspected recruit squad bays. “It’s good to see where our dollars are going,” said Gaydos. “We’re checking out the training first hand. Seeing it makes it more real.”

The United States General Services Administration, as well as five Base Closure and Realignment Commissions, determined Marine Corps Recruit Depot San Diego to be a modern, efficient and vital national asset.

**Aug. 25** – The Retail Clothing Branch and the Defense Logistics Agency implemented new technology, Aug. 25, that will change the way recruits are issued uniforms upon entering training.

Radio Frequency Identification is new equipment to the depot that will shift incoming recruits from handwritten inventory to an electronic issue.

The RFID system uses smart labels that talk to a parent network, instantaneously updating inventory as products enter or leave the warehouse. Scanners read these labels to ensure the product that’s given is recorded properly.

Time management is one of the Marine Corps’ most-stressed attributes. Nothing seems more important than accuracy and achieving it as quickly as possible.

The Defense Logistics Agency recognized the value of time and implemented RFID technology to accomplish quick and precise clothing issue to recruits.

**Sept. 18** - Marine Band San Diego’s Party Band performed during Fleet Weeks Big Bay Family Festival at Broadway Pier, San Diego. The nine piece Party Band played a 40-minute show for those in attendance. The two-day festival was open to the public and helped to kick off Fleet Week. This years Fleet Week San Diego celebrates 100 years of Naval Aviation. Attendees were welcomed to tour ships and static displays provided by the Marine Corps, Navy and Coast Guard.

**Sept. 20** – WASHINGTON – Today, after years of debate and months of preparation, the Defense Department starts on a new footing with the repeal of the so-called “Don’t Ask, Don’t Tell” law that since 1993 has banned gays and lesbians from serving openly in the military.

In addition, former service members separated from the military under Don’t Ask, Don’t Tell based solely on their sexual orientation will be eligible to reapply to return to military service. Patton said their applications will be evaluated using the same standards as all other candidates, and decisions will be based on needs of the service.

Army Maj. Gen. Gary S. Patton, chief of staff for the Pentagon’s repeal implementation team, said as these long-anticipated changes take place, he expects the repeal implementation to stay on track because of the pre-repeal training across the force. In addition, many other existing policies considered “sexual-orientation neutral” remain in place.

**Sept. 24** – Marine Corps Recruit Depot San Diego hosted the 10th annual Boot Camp Challenge Sept. 24, giving civilians a chance to experience a day in the life of a recruit.

The Boot Camp Challenge is a three-mile race around the perimeter of MCRD featuring more than 40 obstacles used in recruit training.

**Oct. 13** – Captain Penny Heisler, Marine Corps Recruit Depot San Diego Branch Medical Clinic officer-in-charge was a prime actor in the U.S. Navy’s 236th Birthday celebration at the depot’s Duncan Hall Galley. As the oldest sailor aboard, her duty was to cut the cake, take a bite of the first slice and pronounce it edible. She then provided a slice to the depot’s youngest sailor, Seaman Gage Farry, MCRD Branch Medical Clinic hospital corpsman, who also tastes it and declares it edible. Admiral Elmo R. Zumwalt, 19th chief of naval operations, authorized October 13 to be the U.S. Navy’s authorized day of recognition in 1972.

**Oct. 19** - Recruit Training Regiment came out on top during a fierce struggle in the fourth annual Powder Puff Football Tournament at Beeson Field aboard Marine Corps Recruit Depot San Diego Oct. 19.

The game was played with flag football rules, and the teams were comprised of female players.

Although Headquarters and Service Battalion dominated the tournament for the past two years, they fell short against RTR and Weapons Field Training Battalion this year.

RTR finished the tournament undefeated and looks forward to defending their championship title next year.

**Oct. 25** – Marines can now buy breakfast items at Duncan Hall’s new breakfast kiosk. The kiosk offers breakfast sandwiches, self-serve beverages, pastries, fresh fruit bowls, coffee, iced coffee, cappuccinos and lattes. “It allows more flexibility with what we can prepare for the Marines,” said Mike Wolfenden, general manager, Duncan Hall, Marine Corps Recruit Depot San Diego. “It also allows Marines to pick up some chow if they don’t have the time to change out of their physical training gear.”

**Nov. 16** – Brig. Gen. Daniel D. Yoo, Marine Corps Recruit Depot San Diego/Western Recruiting Region commanding general presented the 2011 Recruit of the Year Award to Sgt. Carlos F. Hernandez from Recruiting Station San Diego, in a ceremony held during the 2011 Navy League Marine Corps Birthday Luncheon. Other awards presented included 2011 Drill Instructor of the Year, Staff Sergeant Jimmy F. Richard Jr., 2011 Aviation Marine of the Year, Staff Sgt. Bart C. Smith, 2011 Reservist of the Year, Cpl. Marvin E. Umana and 2011 Hospital Corpsman of the Year, Petty Officer 1st Class Brandon Jackson. Businesses in the San Diego area showed their appreciation and sponsored the event, inviting more than 50 Marines and Sailors from Southern California units to attend the event.

## MCRC recruits most diverse group of officers in a decade

The command began the fiscal year with a mission to access

1,650 second lieutenants. In the end, 1,663 of the nations best and brightest reported on active duty, ready to endure six months of intense training at The Basic School here. Of those 1,663 new officers accessed, 85 were African-American, 122 Hispanic and 99 of other ethnic background.

offered previously. Furthermore, students enrolled solely in distance education will receive new benefits.

Since the Marine Corps tuition assistance is capped at \$4500 per fiscal year for each individual Marine, consideration on how to use the GI Bill and degree planning should be of primary concern for

those seeking a college degree.

To be eligible for the Post 9/11 GI Bill, individuals must have spent at least 90 cumulative days of service on or after Sept. 11, 2001, and received an honorable discharge. The exception would be those who were discharged with a service-connected disability after 30 days.

## Major General Melvin G. Spiese

### Parade Reviewing Officer

Maj. Gen. Melvin G. Spiese was commissioned via the Navy ROTC program after receiving a Bachelor of Science degree in civil engineering from the University of Illinois, Urbana-Champaign in May 1976.

After The Basic School, Spiese was assigned to 3rd Battalion, 4th Marines as a rifle platoon commander, executive officer and commanding officer with Company L, and served on the battalion staff. Spiese was then assigned to Marine Barracks Naval Weapons Station, Concord, Calif.

In May 1981 he was assigned to 3rd Bn., 9th Marines as the commanding officer of Company I and officer-in-charge of logistics. In May of 1983 he was transferred to the Navy ROTC Unit at the Illinois Institute of Technology as the Marine officer instructor.

After leaving Illinois in June 1986, Spiese reported to Headquarters Marine Corps and served as the head of regular officer procurement. Following his tour

at HQMC, Spiese attended Marine Corps Command and Staff College and graduated in May 1990. After graduation, Spiese was transferred to Marine Corps Air Station in Iwakuni, Japan and assigned to Marine Aircraft Group 12 as the assistant operations officer and ground combat liaison.

Spiese was assigned to 6th Marines in July 1991 as the executive officer of 3rd Battalion, then to regimental operations . He assumed command of 2nd Force Reconnaissance Company in December 1993.

Upon relinquishing command in July 1995, Spiese was reassigned to U.S. Special Operations Command, serving as a policy officer dealing with counter proliferation of weapons of mass destruction and Marine Corps matters. Upon his departure from USSOCOM, Spiese attended top level school at the U.S. Army School of Advanced Military Studies as a member of the Advanced Operational Arts Studies program. He remained a second year serving as a seminar leader for the Advanced Military Studies Program, a second-year program for majors attending the Army Command and General Staff College.

Spiese was assigned to the Marine Corps Air Ground Combat Center in June 1999 as the director, Tactical Training Exercise Control Group. He assumed command of the School of Infantry (East) in June 2001, and was assigned as the director, Expeditionary Warfare School upon relinquishing command in July 2003.

In March of 2005, Spiese assumed the duties of Commanding General, Training Command, Deputy Commanding General Training and Education Command.

Spiese transferred to U.S.

European Command and served as the deputy director for strategy, policy and assessments in October 2005.

He assumed command of Marine Air Ground Task Force Training Command, Marine Corps Air Ground Combat Center in Twentynine Palms, Calif., in July 2007. He commanded Training and Education Command in Quantico, Va., from May 2008 to August 2010.

Spiese was assigned his current billet as Deputy Commanding General, I Marine Expeditionary Force and Commanding General,

I Marine Expeditionary Brigade in September 2010.

Spiese has been awarded three Legions of Merit, the Joint Meritorious Service Medal, Meritorious Service Medal, three Navy and Marine Corps Commendation Medals, and the Joint Service Achievement Medal. He is a military freefall parachutist and Marine combatant diver.

Spiese has earned a Master of Science degree from the University of Southern California and a Master of Military Arts and Science degree from the U.S. Army School of Advanced Military Studies.
