"Climate Action" is this year's Earth Day theme. The Army has never failed to seize on an opportunity to lead, and so does Fort Buchanan.



The Deputy's Corner: Preparation Response...



Over the course of the last several months United States Army Garrison Fort Buchanan has been developing and refining our 'All Hazards Emergency Action Plan'. What does that mean for our installation community? Well, it should be seamless for all those that have transversed this installation over the years. What you have seen since March is an increase of our Health Protection Condition to ensure the safety and welfare of all who work-liveconduct business here. Our Directorate of Plans, Training, Mobilization, and Security (DPTMS) and in their role as the Installation Operations Center (IOC) have worked diligently in the development of protective measures to ensure we are all safe in the event of an 'All Hazards' occurrence here on the island of Puerto Rico and the installation. So what exactly have they done?

In cooperation with the other garrison directorates, tenants, and partners they have been able in the last nine months to revitalize how we look at disaster response and are better postured to immediately respond to keep the garrison operational. Though they do not do this entirely on their own, they synchronize the efforts and bring all key players into the fold to develop a plan that is feasible and attainable.

Since my arrival we have dealt with two named hurricanes, earthquakes, and a pandemic event. Remarkably this has only slowed down slightly our preparations for what is expected to be a very active hurricane season this year beginning 1 June. Through their efforts, we will be ready and I am proud to work directly with them and our other directorates to ensure success.

In collaboration with the DPTMS and the Installation Safety Office for example, the Safety Officer alongside the Garrison Command Sergeant Major did inspections of the entire installation to ensure all debris and trash were removed or secured prior to the hurricane season beginning. As well as DPTMS will be the lead for the Emergency Preparedness Week the second week of June on the installation.

Their Emergency Manager developed banners and a social media campaign to make sure we are all aware of the season and risks involved. That is just some of how we are preparing for 'All Hazards'.

But how will we respond?

The installation is more ready than it has ever been, we have liaison officers assigned to the IOC from the Puerto Rico National Guard and 1st Mission Support Command that have been imbedded in the planning and will continue to serve as the conduit between our organizations. We have commitments from both these commands to assist where needed to always keep this installation operational, so in turn they will be able to fulfill their assigned missions on this island and globally.

This is a major factor in preparedness and our response. This garrison has limited capabilities when hit with a catastrophic event.

So what does this mean to you?

Expect what you have seen the last couple of months with our response to the COVID-19 crisis. We will continue to have limitations of access on designated days for those that are affiliated with the installation and have either a right or privilege to enter. We are not turning our back on anyone, but this installation will not be a safe haven after a catastrophic event for our retiree or veteran population. We must reserve critical resources for the Soldiers, Sailors, Marines assigned on the installation to be able to execute their missions. We will ensure our patrons and community, when safe to do so, may enter the installation. But this is also your responsibility to be prepared with emergency supplies.

Plan to keep you and your family safe and fed for a minimum of fourteen days after a catastrophic event. Keep in mind our partner employees at the Commissary and Exchange could be effected as well, and without employees we may not be able to open immediately or without some delay. We are all in this together. It is our goal to make sure our community has what it needs for any emergency. Be part of the solution and not part of the problem.



FORT BUCHANAN TEMPORARY CHANGE TO ACCESS GUIDANCE

Visitor Control Center: (787) 707-3995

As of 20 April 2020

This notice expands the Senior Mission Commander's Guidance on Temporary Change to Access effective 21 April 2020 until further notice. THIS POLICY IS SUBJECT TO CHANGE AT ANY TIME – Please watch for updates on our Facebook and Webpage*

1. <u>HPCON Charlie</u>: Due to the emergency situation with Coronavirus (COVID-19), the Senior Mission Commander for Fort Buchanan has implemented Health Protection Condition (HPCON) Charlie with Delta Measures (Substantial - Sustained Community Transmission). To protect the force, we urge our community members to follow the Puerto Rico Governor's Executive Orders restricting movement and the Centers for Disease Control (CDC) guidelines for hygiene and social distancing. Social Distancing will be enforced on the installation. Do not come on post if you are sick or been mandated to be on restriction of movement from your command or health care provider.

2. While Fort Buchanan is at HPCON Charlie:

- a. Borinqueneers' Gate is open 24/7. SPC Frances M. Vega gate is closed for the community. It is open Monday to Saturday from 6 a.m. to 6 p.m., ONLY FOR SERVICE MEMBERS IN UNIFORM, key and essential Common Access Card (CAC) holders and select personnel from the Puerto Rico National Guard supporting COVID-19 operations. Information about HPCON Charlie measures is available at https://phc.amedd.army.mil/topics/campaigns/covid19/Pages/HPCON.aspx.
- b. On Tuesday, Wednesday, Friday, and Saturday **ALL** valid installation access credentials will be accepted at Borinqueneers' Gate from 5 a.m. to 4 p.m. daily and must exit the installation by 5 p.m. The **MWR card and the VHIC pass WILL NOT BE ACCEPTED TO ACCESS THE INSTALLATION.**
- c. Retirees and their dependents will be allowed based on the last digit of their license plate number. On Tuesday and Saturday **ONLY** cars with odd numbers will be allowed on post. On Wednesday and Friday **ONLY** cars with even numbers will be allowed on post.
 - d. Only one (1) person per vehicle. (Exception is paragraph (i.) below for RET DAV)
 - e. Only one (1) person will be allowed to enter the Commissary and Exchange. No dual shoppers.
- f. All active/reserve Service Members and their dependents will have access to visit the Commissary and the Exchange every day of the week; however, preferred days will be Thursday and Sunday with shorter wait time.
- g. Federal employees authorized to visit the Commissary and Exchange will have access to visit the Commissary and the Exchange during the week; however, preferred days will be Thursday and Sunday.
 - h. The trusted traveler program is suspended. No guests allowed.
- i. Retired Disabled Veterans (RET DAV) are authorized to have one (1) authorized person to assist them to shop at either the Commissary or Exchange. Appropriate paperwork and clearance will be vetted at the VCC.
- j. COVID-19 medical screenings to include temperature checks will be conducted for all personnel attempting to access Fort Buchanan. Any individual deemed unsafe will be denied installation access.
- 3. <u>Access Delays</u>: We expect medical screenings to cause major delays at Borinqueneer's Gate and traffic backups. Personnel seeking access to Fort Buchanan must plan accordingly.

4. Commissary (DeCA) and Exchange (AAFES) Operations:

- a. The visitor policy is suspended. Authorized patrons are **NOT** permitted to bring any visitors into the Commissary or Exchange facilities. Only one hundred (100) in-store customers will be allowed at any given time inside the Commissary and Exchange main store, only fifty (50) at the PXtra and only three (3) at the Gas Station Store. Social distancing of not less than six (6) feet is mandated and will be strictly enforced. Social distancing is mandated inside the stores as well as in the lobby, food court, sidewalk and parking areas.
- b. Patrons will bring and wear their own protective equipment eye wear, mask and gloves. None will be dispensed at Fort Buchanan. Patrons should be prepared to stand for long periods of time. Cloth facial coverings are mandated to wear at all times.
- c. Patrons will adhere to the above instructions as well as any other imparted by DeCA, AAFES and Fort Buchanan's Police Force. Non-compliant patrons will be escorted off the installation and will be barred from reentering post as deemed proper.
- 5. This Notice constitutes an **Order** to all individuals within the Fort Buchanan military installation. It is mandatory and punitive in nature. Violators will face adverse criminal and administrative sanctions. The Visitor Control Center hours are from 7:00 a.m. to 4:00 p.m., Monday thru Friday. If you have questions concerning access to Fort Buchanan, please contact the Visitor Control Center at (787) 707-3995.



GUÍA DEL FUERTE BUCHANAN SOBRE CAMBIO TEMPORERO EN EL ACCESO

Este aviso amplía la Guía del Comandante Senior sobre el Cambio Temporero en el Acceso efectiva el 21 de abril de 2020 hasta nuevo aviso. ESTA POLITICA ESTA SUJETA A CAMBIOS EN CUALQUIER COMENTO – Por favor, esté atento a las actualizaciones en nuestro Facebook y página web*

1. HPCON Charlie: Debido a la situación de emergencia con el Coronavirus (COVID-19), el Comandante de Misión Senior del Fuerte Buchanan ha puesto en efecto el Nivel de Condición de Protección de la Salud (HPCON) Charlie con Medidas Delta (Sustancial – Transmisión Comunitaria Sostenida). Con el fin de proteger a nuestra fuerza, solicitamos a los miembros de nuestra comunidad que sigan las Ordenes Ejecutivas de la Gobernadora de Puerto Rico que restringen el movimiento y las guías de los Centros para el Control y la Prevención de Enfermedades (CDC) sobre higiene y distanciamiento social. El distanciamiento social será mandatorio a través de toda la instalación. No venga a la instalación si se encuentra enfermo o ha sido ordenado para estar en restricción de movimiento por parte de su comandante o proveedor médico.

2. Mientras el Fuerte Buchanan se encuentra bajo HPCON Charlie:

- a. El portón Los Borinqueneers' está abierto 24/7. El portón Especialista Frances M. Vega está cerrado para la comunidad. Está abierto de lunes a sábado, de 6 a.m. a 6 p.m., SOLO PARA MIEMBROS DEL SERVICIO EN UNIFORME, personal clave y esencial con tarjeta de identificación (CAC) y personal selecto de la Guardia Nacional de Puerto Rico en operaciones de apoyo del COVID-19. Información sobre HPCON Charlie con Medidas Delta se encuentra disponible en: https://phc.amedd.army.mil/topics/campaigns/covid19/Pages/HPCON.aspx.
- b. Durante martes, miércoles, viernes y sábado **TODAS** las credenciales válidas de acceso a la instalación serán aceptadas en el portón Los Borinqueneers de 5 a.m. a 4 p.m. diariamente y deberán salir de la instalación a las 5 p.m. La tarjeta de MWR y el pase VHIC NO SERAN ACEPTADOS PARA ACCEDER A LA INSTALACION.
- c. A los retirados y sus dependientes se les permitirá el acceso en función del ultimo dígito de su número de tablilla. Los martes y sábados **SOLO** se permitirán vehículos con números impares (nones) en la tablilla. Los miércoles y viernes **SOLO** se permitirán vehículos con números pares en su tablilla.
 - d. Sólo una (1) persona por vehículo. (Con excepción a lo descrito en el párrafo (i.) abajo para los Retirados DAV.)
 - e. Sólo una (1) persona se le permitirá el acceso para entrar a la Comisaría y el PX. No clientes en pareja.
- f. Todos los miembros del servicio activo/reserva y sus dependientes tendrán acceso para visitar la Comisaría y el PX todos los días de la semana; sin embargo, los días preferidos serán jueves y domingo con un tiempo de espera más corto.
- g. Los empleados federales autorizados para visitar la Comisaría y el PX tendrán acceso todos los días de la semana; sin embargo, los días preferidos serán jueves y domingo.
 - h. El programa de viajeros de confianza está suspendido. No se permiten visitantes.
- i. Los retirados DAV están autorizados a tener una (1) persona autorizada para ayudarlos con sus compras en la Comisaría o el PX. La documentación apropiada y la autorización serán revisados en el Centro de Control de Visitantes.
- j. Se realizarán exámenes médicos COVID-19 que incluyen cotejos de temperatura para todo el personal que intente acceder al Fuerte Buchanan. Cualquier individuo que aparente ser un riesgo de seguridad se le negará el acceso a la instalación
- 3. <u>Demoras en el Acceso</u>: Esperamos que los exámenes médicos causen demoras mayores en el portón Los Borinqueneers y retrasos en el tráfico. El personal que busca acceso al Fuerte Buchanan deberá planificar por consiguiente.

4. Operaciones de la Comisaría (DeCA) y el PX (AAFES):

- a. Se suspende la política de visitantes. Los clientes autorizados **NO** están permitidos a traer ningún visitante dentro de las facilidades de la Comisaría o el PX. Sólo se permitirán cien (100) clientes en la Comisaría y la Tienda Principal del PX a la vez. En el PXtra sólo se permitirán cincuenta (50) y en la tienda de la Estación de Gasolina tres (3). El distanciamiento social no menor de seis (6) pies es mandatorio y se hará cumplir de manera estricta. El distanciamiento social es mandatorio dentro de las tiendas, así como en el vestíbulo, área de comida, acera y áreas de estacionamiento.
- b. Se fomenta que los clientes traigan y utilizen su propio equipo protector gafas, mascarillas y guantes. Ninguno será provisto en el Fuerte Buchanan. Usted deberá estar preparado para estar de pie por largos períodos de tiempo.
- c. Los clientes deberán seguir las instrucciones anteriores, al igual que cualquier otra impartida por los empleados de DeCA, AAFES y la Policía del Fuerte Buchanan. Los clientes que no cumplan con dichas disposiciones serán escoltados fuera de la instalación y les será prohibido que puedan re-entrar a la instalación según se considere pertinente.

Soldiers reminded to exercise ethical responsibilities during pandemic

Even in difficult times, the rules still apply.

As the coronavirus continues to spread nationwide and the economy feels its impact, the Army Office of the General Counsel warns Soldiers that potential problems could arise if they choose to start fund raising campaigns for themselves or other Soldiers.

Some Soldiers or federal employees may have spouses or family members who have lost their jobs during the nationwide lock down. Those shouldering additional financial burdens may want to turn to popular crowd-sourced fund raising websites such as GoFundMe or Kickstarter.

John Kent, associate deputy general counsel at the Army Office of General Counsel and expert in ethics, said Soldiers should familiarize themselves with which gifts are acceptable.

"A gift is OK in some instances and not OK in others," Kent said. "The overarching rule is it's not OK when the gift is either given because of the individual's status as a Soldier or an Army employee, or when it comes from a prohibited source. But there are exclusions and exceptions to this rule that may apply."

Soldiers and Department of Defense employees cannot use their status as a service member or government employee as a means for soliciting funds. Further, DOD regulations generally prohibit Soldiers from receiving funds from "prohibited sources" - such as companies or private organizations that do business with or have vested interests with the DOD. Soldiers and employees also cannot receive donations from federal personnel who earn a lower annual income.

Fund raising campaigns could be organized, but rigorous accountability of donors and records of sources must be kept.

"They are theoretically possible," Kent said. "But the pragmatic problems with conducting them within the rules that we have to follow make that extremely difficult."

Soldiers who choose to run such campaigns must be able to provide records, or otherwise they may have to return the funds. Kent said the problem could be escalated further if patrons donate anonymously.

"Some platforms cannot or will not identify who the real donors are," he said. "And that poses a real problem."

As an alternative to fund raisers, Soldiers can also apply for the Army Emergency Relief program to receive funds in financial emergencies. The funds can be applied towards utilities, rent and other living expenses.

As Soldiers become more publically visible in the fight against the global pandemic, they should understand the rules on accepting gifts from the public. Members of the National Guard, for instance, have deployed to assist hospitals in various states throughout the country, prominently in New York City and the northeast.

Soldiers generally may not accept gifts exceeding \$20 in value from a prohibited source or given to them because of their official positions as Soldiers, and such gifts must not total more than \$50 annually from any single source. Those gifts could include donations of protective equipment like masks and gloves. Unless an exception to the rule applies, gifts of cash may never be accepted from a prohibited source or because of one's status as a Soldier.

Soldiers who have fallen ill with COVID-19 or another illness can receive certain gifts from their fellow Soldiers, to include food and other comfort items subject to certain limitations. Mr. Kent recommends seeking advice from an ethics counselor before accepting or giving such gifts.

There are some exclusions and exceptions to the base rule against accepting gifts from prohibited sources or based on their official status. For example, in addition to the \$20 gift rule, Soldiers may accept gifts from prohibited sources if the gifts have been made available to everyone or all military members. For example, during Operation Desert Storm, Busch Gardens offered free admission to all military members and their families. Certain social gatherings that meet specific exceptions may also be acceptable. Soldiers could potentially accept financial assistance from a crowd-sourced relief fund, provided that it does not discriminate based on position, rank or pay.

Additionally, Soldiers may benefit from gifts that are accepted by authorized senior Army leaders on behalf of the Army and then distributed to Soldiers and Army organizations supporting Soldiers. Such gifts could include equipment and discounts or free passes to entertainment events like concerts or sports games.

Soldiers should contact their ethics advisors if they are offered or have received excessive gifts from prohibited sources. Kent said such cases should be reported as early as possible.

Soldiers who have any questions regarding acceptable gifts can consult ethics counselors through their first sergeant or chain of command. Questions on whether donations from prohibited donors or fellow Soldiers are acceptable should also be directed to counselors, he said. "If there is a way for a Soldier to accept a gift within the applicable gift rules the ethics counselor will try to identify how that can happen."

Summer Fire Safety

Fire Safety around the Home:

- Keep dead grass and weeds cut to ground level along fences.
 - Use caution when operating gas powered lawn equipment.
 - Watch for sparks from blades of edger's and mowers.
- Keep heavy brush, large shrubs or tree limbs from growing among electrical power lines.

Fire Safety for Barbecue (BBQ):

- Ensure your grease-catch is properly in place and cleaned.
- When using gas grills, make sure connections and hoses are in good condition and tightened to prevent leaks. Use soap water at connectors to find leaks.
- For charcoal grills, use only approved lighter fluids, never gasoline or other flammable/combustible liquids.
- Have a fire extinguisher, 5 gallon water-filled bucket or connected water hose.
 - Charcoal should always be stored in cool, dry locations.
- Do not barbecue under carports, inside garages, within 10 feet of your home or within 25 feet of any building exit, window or HVAC unit.
- Ensure the charcoal is thoroughly extinguished by soaking it with water before discarding.
- **NEVER** leave cooking items unattended, not even a second!
 - **NEVER** allow children near active cooking area.

Fire Safety for Camping:

- Ensure your tent meets flame resistance testing and certification.
- Ensure tent is placed in a clear area, free of excess combustibles, such as tall grass, brush or trees.
- Campfires should located at least 50 feet from tents and downwind. Not authorized on Post.
- **NEVER** use open flame devices or gas powered lanterns inside tents.
 - Use ONLY battery powered lanterns.
- Keep a fire extinguisher, bucket of water or sand nearby at all times.
- Turn off fuel lanterns, gas stove and thoroughly extinguish fire before going to sleep or leaving camp site.

USAG Fort Buchanan mandatory guidance on face coverings



GUIDANCE ON THE USE OF CLOTH FACE COVERING IN PUBLIC AREAS

Effective immediately, ALL individuals (Military Personnel, DoD Civilian Employees, Family Members, DoD Contractors, and all other individuals on USAG Fort Buchanan installation) WILL BE **REQUIRED** to wear protective cloth face coverings in public areas or work centers when they cannot maintain six feet of social distance

You MUST wear protective cloth face coverings at:

- Access Control Points/Public Interactions Guards at the gates may require the lowering of face covers for facial identification.
- PX Food Court (For pick- up of To Go orders)
- PX (Main Store, Gas Station Store and PXtra)
- Commissary
- Community Club (For pick- up of To Go orders)
- IHG (El Caney Lodging)
- Installation Legal Office
- Rodriguez Army Health Clinic

Use of Cloth Face Coverings to Help Slow the Spread of COVID-19

How to Wear Cloth Face Coverings

- fit snugly but comfortably against the side of the face
- · be secured with ties or ear loops
- be able to be laundered and machine dried without damage or change to shape

CDC on Homemade Cloth Face Coverings

CDC recommends wearing cloth face coverings in public settings where social distancing measures are difficult to maintain (e.g., grocery stores a pharmacles), especially in areas of significant community-based transm

CDC also advises the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the cloth face covering without assistance.

The doth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserve healthcare workers and other medical first responders, as recommende current CDC guidance.

Fort Buchanan implements further preventive COVID-19 actions

As developments occur of increased community transmission of COVID-19 in Puerto Rico, Fort Buchanan's leadership continues to assess and implement preventive actions to protect the health and safety of the military and civilians authorized to enter the installation.

Fort Buchanan is presently conducting medical screenings at The Boringueneers' Access Control Point, consisting of questions regarding visitor's activities in the last 14 days such as; travelling to the United States, visiting nursing homes or hospitals, or having contact with persons who tested positive for coronavirus.

Other questions point out possible symptoms such as fatigue, trouble breathing, muscular pain, cough, diarrhea and sore throat. According to the Center for Disease Control and Prevention (CDC) these symptoms may appear 2-14 days after exposure to the virus. Individuals who are deemed unsafe are denied access to the installation. This does not mean that said person is positive to COVID-19.

Reserve Soldiers from the 215th Military Police Detachment, 301st Military Police Company, 613th Military Police Company, and 49th Multifunctional Medical Battalion from the 1st Mission Support Command are providing support to the garrison, conducting medical screenings and enforcing guidelines, such as social distancing and the wearing of face coverings.

While from personnel the installation's Directorate of Emergency Services – Police Department conduct ID card checks and ensure individuals are in compliance with the Governor's Executive Order restricting vehicle movement based on the last numbers of their license plates.

Non-compliant individuals on these preventive measures are denied access or escorted out of the installation.



Due to the medical screenings, personnel who seek access to Fort Buchanan are experiencing delays and traffic backups.

Also, authorized personnel visiting the Commissary and the Exchange experience waiting in line for some time while social distancing and preventive measures are being implemented at these facilities.

Fort Buchanan encourages personnel seeking access to the installation to plan accordingly and to practice good patience to ensure the protection of others.

Everyone's daily lives have been impacted by these and other protective measures in this unprecedented and on-


